However, we provide comprehensive blood testing, i.e., all 44.

Analysis Fee includes all seven of the above items listed for Tissue Mineral Hair Analysis, only in relationship to blood chemistry testing. In other words:

Item #1 - You are emailed your Blood Chemistry Lab Requisition, along with a list of local laboratories you to choose from near you to have blood drawn.

Item #2 - Website Passcodes for "Fasting Instructions" are provided.

Note: All Female Hormone Tests for menstruating or menopausal women, or those who have had a hysterectomy (partial or complete) now include Adrenal and Melatonin Hormone Testing.

In other words, though on our website we have provided a pop-out webpage for Adrenal Hormone Saliva Testing, this test and the information it provides is included in both Male and Female Hormone Saliva Tests.

#### Analysis Fee includes all of the above items listed for Tissue Mineral Hair Analysis, except #4 - Lab's Fee and with the following changes in Item #1 and #7:

Item #1 - Fee includes Saliva, Stool and/or Urine Lab Kit and postage to mail it/them to you through USPS.

Item #7 - A 30 minute prepaid Telephone Consultation with Dr. Smith is provided with saliva and stool testing and a 15-minute Telephone Consultation is provided with the bone urine test.

Re: Item #4 - Because our Lab will file the insurance claims for payment for their Lab Fee to analyze your specimens and send Dr. Smith your Lab Report, their Lab's fee is not included in Dr. Smith's Analysis Fee.

Therefore, if you have been provided a QUOTE ORDER INVOICE, it will indicate three fees to the right of the title of the saliva, stool and/or urine test.

- Schedule A Fee if you provide your insurance information and this Fee amount by check or Card (Credit or Debit) information on its Lab Requisition (included in the Lab Kit), the Lab will file your claim.
  - If your insurance pays the Lab the "List Price" amount indicated on the Quote Order Invoice, the Lab will reimburse you the entire Schedule Fee amount you prepaid.
  - If your insurance paid none, some, but not all of the List Price, they will not reimburse you the Schedule A Fee amount you prepaid, however, that amount is all that you will have to pay for
- Schedule B Fee if you do not have insurance or do not wish to provide your insurance information, then you will send a check or provide Card Information on your Lab Requisition for the Schedule B Fee amount. This is our specific client discount amount that the Lab provides for Dr. Smith's clients.
- List Price: The actual cost of the Lab's Fee and the amount they charge Insurance companies. So the List Price does not apply to our clients.

### **Dietary Analysis & Dietary Plans**
