

# Scars, Tattoos, Piercings, Vaccination Puncture Sites And Other Interference (To Healing) Fields



What is an Interference Field? An Interference Field (IF) is anything that disrupts the normal flow of bioenergy in the body. In other words, an IF is a trauma that blocks or inhibits the flow of blood, nerve, nutrients, lymph and/or energy through the body. An IF can be located anywhere in the body and can be mental, emotional or physical. Interference Fields "interfere" with the body's ability to function and heal itself properly and completely. Once a physical trauma site has been identified as an interference field from a Clinical Nutrition Analysis by Dr. Smith, you are provided these ancient mineral packs and instructed in how to massaged them into the IF sites (Scar, Piercing, etc.) in a specific order to open the circulation of blood, lymph and nerve flow previously blocked by the Interference Field. This procedure requires a specific order of application for detoxification to prevent further blockages.

**Mental/Emotional Traumas** are caused by physical and verbal abuse, long-term negative thinking and stress (real and imagined). **Electro-Magnetic Fields (EMF)** - Interference Fields may also be caused from exposures to artificial electrical frequencies (AEFs), such as computers, cells phones, TVs, home appliances, etc., which interfere with the healthy function of the electrical system of the human body. ## INTERFERENCE FIELDS CAUSE PAIN AT DISTANT SITES

Interference Fields can cause pain in distant areas of the body that "seem" unrelated to the IF site. For example, when a C-Section scar blocks the nerve, blood, and lymph flow to the upper Gastro-Intestinal system, this can cause a myriad of health concerns, such as Heartburn, Gas, Indigestion, Nausea, Vomiting, Diarrhea, Stomach Pain, Gall stones, Shoulder pain and more. It's a fact -- Interference Fields create clinical symptoms that are rarely associated to their real cause. However a Clinical Nutrition Analysis can identify Interference Fields and through Clinical Nutrition Therapy, you can correct their cause.
