(Note: Healed Conditions = a small red block on the 0 score line.




Figure 2 - Improvement in the 11 Specific Skin Conditions

As of 5/2/11 improvement or healing observed in each 11 skin conditions. Updated Reports will indicate which of the <u>improved areas</u> below have healed, improved to the next level of healing, but not yet healed and/or have attained optimal healing. Wrinkles are a skin condition that may be healed when new skin cell growth can be generated.
