Tab #3 - Empty Section?

- If there is no information in this section, this means you have requested to have your Report of Findings appointment with Dr. Smith to review your Clinical Nutrition Analysis Evaluation and Laboratory Reports, Dietary Plan (Eating Guidelines) and/or other testing and evaluation documentation in this P.E.P. Binder, whichever applies to you, prior to receiving your therapeutic supplements. Thus, the information below will be included with your first Auto-Shipment, so you may insert them in this section, at that time.

Therapeutic Supplement Program of Care (POC)

- **Purpose** - The "Therapeutic Supplement Program of Care," often referred to as the POC, provides the specific therapeutic supplements in your clinical nutrition program, along with its daily dosage, purpose and other special instructions. The "**Special Orders**" section of the POC lists five columns of products and/or supplements to meet your health maintenance needs.
- **SPECIAL ORDER** are your purchases. Your therapeutic supplements are automatically shipped monthly. However, Special Orders are shipped to you only when requested, whether they are shipped with your therapeutic supplements or separately. You select your own items to purchase as needed and some may be recommended by Dr. Smith from the **HEALTH MAINTENANCE LIST** (Tab #1 in PEP Binder) or as needed during various educational consultations, such as the Herbal First-Aide, Microbial Kit, or from the **HEALTH CHEST e-book**. **Special Orders** included personal care, culinary, health equipment, air and water purifiers, and First-Aide products, Table Food and other important products to promote and maintain health.
 - **When To Place Special Orders:** You may call or email to place Special Orders at any time. However, when you list them at bottom in your monthly Inventory Email, i.e., **Column #1 dates of your Auto-Ship Schedule**, you may save shipping costs. An Inventory Reminder Email that it is time to provide your inventory and list any Special Orders is emailed the day before its due date. You may review a copy of your Auto-Ship Schedule in front of Index Tab #1 and it is also included in each **Auto-Ship Email Reminder**.
- **POC Updates** - As your body heals and changes, your POC will be adjusted to meet your next level of nutrient requirements to assure continued healing progress. Therefore, when you receive a new POC, the previous one automatically expires. By keeping all expired POCs in this sections by date, you will have a complete, historical record of the clinical nutrition therapy, that has assisted in improving your health and in time, your "Maintenance Supplement Program of Care (MPOC) will list any supplements you may require to maintaining your optimal health for the rest of your life. All instructions or updates will be typed on your Invoice to the right of any new supplements when sent for the first time, if your updated POCs is not included with your Auto-Shipment. In these cases, your POC will be updated as soon as possible and iled to you or sent through U.S.P.S., if you have no email. Therefore, please check emails when shipment arrives.
- **The INV (the first) Column of your Program of Care (POC)** - provides a place to record, in pencil, your monthly inventory to assist you in providing your inventory on the Column #1 dates of the **Auto-Ship Schedule**.

Therapeutic supplements are provided for nutritional purposes only and not for the treatment of any medical disease, disorder or condition.

- **Auto-Ship Policy (Tab #10)**

It is very important to read and **thoroughly understand** these policies so that our auto-shipment services may be provided to you efficiently, timely and with clarity regarding any questions you have now or in the future. It each client's responsibility to review these policies before contacting our office with questions.

All policies are upheld without exception, even if clients have not taken time to read these policies. This applies to all policies of **Advanced Clinical Nutrition**, as communicated in signed and returned Informed Consents, such as the **"Informed Consent – Business Policies," "Informed Consent – Clinical Nutrition Program,"** etc.

Revised or updated policies for general business, client services and auto-shipment purposes are posted on the "Policies and Procedures" webpage.

Clients who do not take time to read and adhere to them often cause delays, extra time, money and efforts for themselves and us, which may lead to interferences in their healing momentum and the success of their program. Repeated disregard for our policies may lead to our discontinuing the client's services.

Most Frequently Required Initial Therapeutic Supplements List

- Each therapeutic supplement program is uniquely designed by Dr. Smith for your individual biochemistry and physiology and, therefore, this unique combination of clinically-formulated, therapeutic supplements listed on your initial and updated Program of Cares (POCs) will not help anyone else like it will your mind and body.
- Because each of us lives in a toxic environment, where we are exposed daily to chemicals, heavy metals, and other pollutants in our air, food and water, including electro-magnetic fields and the adverse affects of scars, piercings, vaccination puncture sites (and the toxic substances in them), etc., by the time people seek our services, they have a multiple nutrient deficiencies, biochemical imbalances, organ/gland/body system dysfunctions, disease patterns, as well as, diagnosed diseases. Therefore, what is common to "every human," is a program that is designed for cellular and tissue detoxification and nutrient repletion.
- Therefore, this is a list of the most frequently required therapeutic supplements for new clients in various combinations unique to the results indicated on their biochemical tests (blood, urine, saliva, hair, etc. and/or Nutritional Evaluations and lists additional benefits of each supplement, besides those listed on your Program of Care sheet. What is listed on your POC are the priority purposes for dispensing the therapeutic supplement s to you.
- Note: Though there are a number of supplements listed in these pages, this does not mean all or any will be recommended to you. However, for those that are, you now have this information in advance.

Therapeutic Supplements

The Product Companies, who manufacture the Therapeutic Supplements provided through **Advanced Clinical Nutrition**, distribute only to nutritional doctors, like Dr. Smith, because their products are highly potent and clinically-formulated for therapeutic use. Therefore, they should never been taken without first being nutritional testing or evaluated to know scientifically that you need them, and then taken only under professional guidance.
